Membership Agreement

eBraiding.net / eNaturals.net is a company formed to organize the hair braiding and natural hair care environment, fight to protect and preserve the rights of hair braiders and natural hair care professionals and provide National Directory and Advertisement Services exclusively for hair braiding and natural hair care salons in the United States and Canada.

As a membership based advocacy organization, the company's mission is to help uplift the hair braiding and natural hair care industry into a healthy environment, and to promote unity within the hair braiding and natural hair care community. In working with and assisting our members, ebraiding.net seeks to develop standards, rules and regulations for hair braiders and natural hair care professionals so as to enhance the overall growth of the industry.

Members of the organization are made up of Hair Braiding and Natural Hair Care Salons and Hair Braiders and Natural Hair Care Professionals across the United States and Canada.

Two Types of Membership: **Basic** and **Platinum**.

Every **Basic Member** pays a non-refundable **Administrative and Support fee** in the amount of **\$99 every year**.

Those of the **Basic Members** who would like to be listed on the **Online National Directory and Advertisement Services** platform pay an additional **\$250 per year**. They will be listed as **Platinum Members**.

How to register for Membership?

1. Fill out the Membership Registration Form
2. Pay the **Annual Administrative and Support fee: \$99**. **All payments are non-refundable**. For existing Members, the fee payment is due between **January 1 and February 28 every year**. For new members, the fee will be prorated if registration is done outside of January 1 and February 28.
3. Sign the present Membership Agreement form
4. The membership will be scheduled to be activated as soon as the full annual administrative and support fee payment is made. There are no

adjustments to the administrative and support fee.

5. For **Platinum Members**, pay additionally the **\$250 yearly activation fee**. If you choose to take advantage of the installment plan, you will be required to provide a **valid source of payment** (Checking Account, Credit Card, or Bank Card) from which the installment plan will be set up. **All payments are non-refundable**.
The membership will be scheduled to be activated as soon as the full membership payment is made. Exceptions will be made for those who qualify for the installment plan. In these cases, the membership will be activated as soon as the first (1st) payment is made.
The renewal for the Platinum Membership will be made 12 months from the date of the initial membership activation.
